**Information for NFs:** These are the instructions DADS will be providing to the LAs (both LIDDAs and LMHAs) the week of Sept. 12. **Please read them.** When you call the LA to schedule an IDT and the PE has been identified as a "false" positive by the LA, they will provide instructions to you on what type of PL1 needs to be entered to clean these up. You do not submit a 1013 form in these cases as that form is only used to request a positive PL1. **This document serves as the permission to change the PL1.** Please create a note on the PL1 to indicate the permission came from HHSC PASRR and keep this document on file.

# Info for LAs: Requests for IDT Meetings for Individuals with False Positive MI PEs

As you may be aware, a previous data conversion caused the TMHP system to, in some cases, generate false positive PEs for MI on PEs completed prior to March, 2014. Since NFs are required to conduct and enter annual IDTs for all individuals with a positive PE status, you may start receiving phones calls from an NF trying to schedule an IDT meeting for these individuals.

If the NF calls to schedule an IDT meeting for someone that has a false positive status for MI only or the MI portion of a dual recorded on the current PE, please let the NF know that it is a false positive. Then the LMHA/LIDDA will instruct the NF to complete a new PL1 as per the scenarios/instructions below:

## 1. MI only False Positives:

If the PE is recorded this way:

- C0300J has None of the Above checked
- C0100 (Dementia) is recorded as "no"
- C0500-C0700 are all recorded as "no"

But C0800 is "yes" ...does this individual meet the PASRR definition of mental illness.

The NF will be required to enter a new Negative PL1 for MI only, with a current date of assessment and F0200 Expedited Admission/Convalescent Care.

If the PE is recorded this way:

- C0300 had anything other than C0300J checked
- C0100 (dementia) is recorded as "no"
- C0500-C0700 are all recorded as "no"

But C0800 is "yes" ...does this individual meet the PASRR definition of mental illness; or

C0800 is "no" but the status of the PE is still positive for MI.

The NF will be required to enter a new Positive PL1 for MI only, with a current date of assessment and F0200 Expedited Admission/Convalescent Care.

The LMHA will get an alert and a new PE needs to be completed. This is needed to clear the record with an accurate evaluation.

#### If the PE is recorded this way:

C0100 (dementia) is recorded as "yes" but the status of the PE is still positive for MI.

The NF will be required to enter a new **Negative PL1** for MI only, with a current date of assessment and F0200 Expedited Admission /Convalescent Care.

# 2. Dual (IDD and MI) PEs with False Positive for MI:

#### If the PE is recorded this way:

Dual PE with dementia as primary for MI (If the false positive is part of a dual PE (IDD and MI).

In this situation, the NF will enter a new PL1 marked yes for IDD and no for MI with a current date of assessment and F0200 Expedited Admission/Convalescent Care.

#### LIDDA will enter a new IDD only PE.

#### If the PE is recorded this way:

- Dual PE with dementia not indicated as primary for MI:
- C0300J has None of the Above checked
- C0100 (dementia) is recorded as "no"
- C0500-C0700 are all recorded as "no"

But C0800 is "yes" ...does this individual meet the PASRR definition of mental illness.

The NF will be required to enter a new PL1 for IDD only, with a current date of assessment and F0200 Expedited Admission/Convalescent Care.

#### LIDDA will complete an IDD only PE.

#### If the PE is recorded this way:

- C0300 had anything other than C0300J checked
- C0100 (dementia) is recorded as "no"
- C0500-C0700 are all recorded as "no"

But C0800 is "yes" or "no"....does this individual meet the PASRR definition of mental illness;

The NF will be required to enter a new Positive PL1 for both MI and IDD, with a current date of assessment and F0200 Expedited Admission/Convalescent Care.

# The LMHA and LIDDA will get an alert and a new PE needs to be completed. This is needed to clear the record with an accurate evaluation.

HHSC PASRR staff is working with TMHP to determine if an automated fix can be made. We will communicate any changes to this process.
